House Rules



Beach Center Parcs

1. Beach access

Access to the beach is without obligation. Beach visitors are prohibited from bringing or using the following goods on the beach and in bathing water:

- · All types of glassware, thermos flasks, glasses, etc.
- Floats such as: boats or other buoyancy aids larger than 1 meter
- Floats for children are allowed.
- Audio equipment (except battery operated devices)
- Photographic and video equipment requiring a 220 volt cable connection is allowed.
- Photo and video equipment may not be used in the beach changing rooms and shower rooms.
- Objects that can cause physical injury to the guest and fellow visitors such as stabbing weapons, syringes (except for diabetics) for drugs, etc. are not allowed.
- Pets (except assistance dogs)

Do not bring unnecessarily valuable items. Goods cannot be deposited at the lifeguard station. Beach personnel are authorized to remove unattended clothing on the beach.

CP is not responsible for the contents of unattended clothing.

Children under 13 must always be supervised by an adult in the swimming water as well as on the beach.

Parents and/or supervisors must ensure that children who cannot swim always wear flotation devices.

For security reasons, certain areas of the beach may be monitored by camera surveillance. The images are kept confidential and are used for your safety and the safety of other users.

2. Refusal of access to and/or removal from the beach.

Access will be denied or stay will be terminated

 Carrying one or more goods as mentioned under point 1;

- Not following instructions/directions of the beach staff and not complying with the regulations;
- In case of repetition, access can be denied for an (in)definite period of time;
- Being under the influence of alcohol and/or drugs.
- Committing theft (theft will always be reported to the police).
- Suffering from contagious diseases or having open wounds.
- In case of non-compliance with health, safety or sanitary measures, even if they are exceptional or temporary (e.g. COVID-19 preventive and protective measures).

If your stay at the beach is terminated early because of the above reasons, it is without refund of any entrance fee.

3. Staying on the beach

- Swimming is only allowed at a green flag.
- In case of a red flag, swimming or bathing in the swimming pond is strictly prohibited.
- The guarded swimming area is demarcated with a buoy line.
- Swimming or bathing in the unguarded areas is prohibited at all times.
- Beach guests must strictly follow the instructions of the lifeguard and or authorized person.
- All trash must be disposed of in the trash cans provided.
- It is forbidden to walk on the jetties and to jump from the jetty into the water. Children must be supervised by an adult at all times when entering the jetty.
- Do not dig wells in the sand.
- Visitors should leave the beach during thunderstorms.
- Running is not permitted for safety reasons and nuisance to other visitors.
- The use of air mattresses, air tires and other floating objects are allowed if smaller than 1 meter.
- Protect yourself and your family from the sun, greasing is the message

4. Sanitary measures

 Some exceptional measures, depending on the health, safety and health situation, may be implemented - strictly - for a limited time

5. General

- Persons and/or groups found or expected to disturb order or peace may be denied access to the beach and/or restaurants.
- Every visitor must behave in such a way as to ensure order, safety and hygiene.
- Service and/or staff areas are not accessible to visitors
- In case of excessive crowding on the beach, in connection with the maintenance of safety, the number of visitors may be limited. In connection with maintaining the safety of visitors, the management may reserve the right to change the opening hours of the beach and close all or part of the complex.
- It is necessary to respect the opening and closing times.

6. Liability

The management accepts no liability for theft, damage to visitors' property on the beach, parking lot, bicycle parking and other accommodations. Visitors who damage Center Parcs property will be held liable for all costs arising from repairs and/or replacement.

Access to the beach is at your own risk.

7. Flotation devices

Parents and/or guardians should ensure that persons who cannot swim properly wear flotation devices. They are an aid to floating, but are not a guarantee against drowning. Even when using flotation devices, persons who cannot swim properly should swim only when accompanied by an adult.
